- Publication or communication to any unauthorized persons of experiences of escape or evasion from enemy-occupied territory, internment in aneutral country, or release from internment not only FURNISHES USEFUL INFORMATION TO THE ENEMY but also JEOPARDIZES FUTURE ESCAPES, EVASIONS AND RELEASES.
- 2. Personnel will not, unless authorized by the Assistant Chief of Staff, G-2, War Department General Staff, publish in any form whatever or communicate either directly, or indirectly, to the press, radio or an unauthorized person any account of escape or evasion of capture from enemy or enemy-occupied territory, or internment in a neutral country either before or after repatriation. They will be held strictly responsible for all statements contained in communications to friends which may subsequently be published in the press or otherwise.
- 3. Evaders.escapees, or internees shall not be interrogated on the circumstances of their experiences in escape, evasion or internment except by the agency designated by the Assistant Chief of Staff, G-2, War Department General Staff, or the corresponding organization in overseas theaters of operations. In allied or neutral countries, American Military Attaches are authorized to interrogate on escape, evasion and internment matters.
- 4. Should the services of escaped prisoners of war, evaders, or internees be deemed necessary for lecturing and briefing, such services will be under the direct supervision of the agency designated by the Assistant Chief of Staff, G-2, War Department General Staff, or the corresponding organization in overseas theaters of operations.
- 5. Commanding Officers will be responsible for instructing all evaders, escapees, and internees in the provisions of this directive which supersedes letter, AG 383.6 (5 Nov 42) OB-S-B-M, 7 November 1942, subject: Instructions concerning Publicity in Connection with Escaped Prisoners of War and other previous instructions on this subject.

When I landed at 0130 hours, 5 July 1944, approximately fifteen miles north of PITHIVIERS, I buried my chute and took off. Soon the Jerries who were hunging me came near a farmhouse. However, a woman saw me and brought another chap who checked my identification discs. This man took me down a road and showed me a large farmhouse. It was now about 0600 hours.

I decided to take a chance, went up to the farmhouse, and found another American, lst Lt WILLIAM LAFFERTY. The chap who owned the farmhouse fed us and took us into the woods where we hid all morning while the Jerries hunted us. About 1400 hours our friends came and took us to OUTARCES, where we stayed for about eight days, until 13 July. While there, my radio man came and spent a few days and nights with me. On the 18th the three of us, LAFFERTY, JONES and I split up. I went to a farm near GRENEVILLE-EN-BEAUCE, staying there until 23 July. On that day my radio man joined me and we went to CHARMONT. The third day we were there we met up with our bombardier (26 July). We were then taken to the house of the farmer where I had met my pilot, Lt MEADE. After spending the night there, the radio man and I were taken back to CHARMONT for two days, until 29 nJuly.

Once again I was taken back to the house of the farmer who had first helped us, discovering when we arrived that the pilot and bombardier had already left for ETAMES and PARIS. The radio operator, Lt LAFFERTY and I spent the night until 0900 hours 30 July.

We then took a train to PARIS with two Resistance chaps who took us to a cafe in the depot where we met additional Resistance people. These people took all off us to various places in PARIS. LAFFERTY and I were taken to the same place where we remained until the Americans entered PARIS.

We also stayed with M TUÇSON on the Blvd Gouvieux-St-Cyr until the Americans arrived. This man was one of the heads of the Resistance in PARIS.
