SECTION IIA. Summary

During the period 1 May 1967 through 16 May 1967, the Battalion participated in Operation Prairie IV. On 16 May 1967 Operation Prairie IV was terminated for 1st Battalion, 4th Marines (Rein), and on 17 May 1967 the Battalion commenced Operation Hickory. On 28 May 1967 the Battalion ended Operation Hickory and on 29 May 1967 began Operation Prairie IV once again. On 30 May 1967 Operation Chocotaw began. On 12 May 1967 Lieutenant Colonel T. J. WILLIS was transferred from 1st Battalion, 4th Marines (Rein) due to being thrice wounded. On 13 May 1967 Major R. C. BELL assumed duties as the new Commanding Officer of 1st Battalion, 4th Marines (Rein). On 26 May 1967 Major E. H. BOYD rotated to CONUS, and on 27 May 1967 Major M. K. SHERIDAN assumed the duties as the Executive Officer of the Battalion.

B. Problem Areas/New Developments

At the beginning of the reporting period, the Battalion was plagued with a shortage of personnel. However, the replacements received quickly alleviated this shortage. Toward the end of the month the Battalion again began to have personnel shortages due to the number of personnel dropped because of wounds and rotating to CONUS. The shortage of officers still remains critical with ~~ten~~ (10) needed to bring the Battalion up to manning level. At the close of the reporting period rifle companies were averaging approximately 20 men below T/O, and an average of 20 - 30 non-effectives.

E. Morale, Postal Affairs, Liberty, R&R, PX

Morale is excellent. The Battalion received R&R quotas to Okinawa, Manila, Tokyo, Hong Kong, Bangkok, Penang, Kuala Lumpur, Singapore, Hawaii, and Taipei. While PX facilities were available to all hands at Dong Ha, PX stock has been inadequate. Particular shortages of film, cigarettes, stationery, and soft toilet articles has been prevalent. Postal services continue to be satisfactory.

F. Chaplain's Activities

On 11 May 1967 Lt A. S. KIRK relieved Lt S. E. ALMASY, who rotated to COMUS, as Battalion Chaplain. Throughout the reporting period, services were held for both Protestants and Catholics. On 20 May 1967 the Chaplain participated in the groundbreaking ceremonies for the Chapel, 11th Engineers. On 24 May 1967 a memorial service was held for the personnel killed in action from "A" Company. Counselling continued throughout the month with 16 cases conducted.

INTELLIGENCESECTION III.

- A. General (Period covered: 1 May to 31 May 1967). During the reporting period the Battalion was located at DONG HA Combat Base with forward elements providing security for the engineer project on the GIO LINH-CON THIEN fire break. On 15 May the Battalion assumed OPCON of the C.C-P units in the DONG HA area. During this period the Intelligence Section was engaged in supporting the forward elements at GIO LINH-CON THIEN and the C.C-P units.
- B. Enemy Situation in the Battalion Operating Area.
1. The enemy encountered in the GIO LINH-CON THIEN area were NVA. The enemy infantry units were regular line infantry, equipped with AK-47 assault rifles, S&S carbines, RPD L.G., B-40 (R.G.) rocket launchers and ChiCom grenades. These units were reinforced with sapper units, whose mission was to breach defensive wire with satchel charges to make way for the assault forces. Transportation units were attached to move casualties to the enemy's rear. Fire support was provided by 60mm and 82mm mortars and 82mm recoilless guns (model B-10). During the 8 May attack on CON THIEN, intelligence sources stated that the wounded NVA were transported to a hospital at AN NHA (YD123725). Besides NVA infantry, North Vietnamese artillery (suspected 76mm and 100mm) was used to shell CON THIEN almost daily (receiving from 2 to 60 rounds a day).  
Interrogation of NVA POW's, captured 8 May at CON THIEN, identified the enemy units which attacked CON THIEN as 4th Bn, 812 Regt, 32AB NVA Div; 6th Bn, 812 Regt, 32AB NVA Div (aka THU BON or BAN VI Regt).
  2. Terrain.
    - (a) Critical Terrain Features. These included the high ground at CON THIEN (YD114702) which served as a strong point for friendly forces; hills 56 (YD140733) and 48 (YD114734) which were used by the enemy for mortar and AR attacks upon CON THIEN.
    - (b) Cover and Concealment. Thick undergrowth, heavy shrubbery which was knee-high to man-high, and elephant grass offered good concealment. Underground cover and sand-bag bunkers were necessary due to lack of natural cover.
    - (c) Avenues of Approach. The main avenue of approach was a 10 kilometer dirt road from CAM LO to CON THIEN. Others were the Fire Break dozed from GIO LINH to CON THIEN, and footpaths and trails interlaced in the area to the immediate south of the DMZ.
  3. Weather. The start of the dry season influenced the weather in the operating area. Rising temperatures (to 105°) with humidity averaging 80%, were normal for the reporting period. Visibility was good, with the exception of 3 or 4 days of haze. Cumulative rainfall was light, though heavy rain of 1 or 2 hours duration occurred in the mid-afternoon.

OPERATIONS/TRAININGSECTION IV

A. MISSION. During the period 1-31 May 1967 the 1st Battalion, 4th Marines was OPCON to the 9th Marine Regiment. The period 1-20 May the Battalion (\*) was located at CON THIEN outpost and from 21-29 May 1967 at YD 147617. Operations and/or activities worth note on the dates indicated.

1-16 May The Battalion continued mission of defending CON THIEN Outpost with 2 rifle companies and the Alpha command group and clearing a 300 meter wide area around CON THIEN.

17-29 May 9th Marines operations order 5-67 (Operation HICKORY) directed the Battalion to continue assigned mission at CON THIEN and reinforce 1st Battalion 9th Marines on order.

29 May The Battalion was relieved in place by elements of 2nd Battalion 3rd Marines at YD 147617 and returned to DONG HA Combat Base.

30 May The Battalion departed DONG HA to join the 4th Marine Regiment vic YD 546323.

B. During the period 1-29 May Company B remained OPCON to the 12th Marines providing security for the Composite Arty Battalion at GIO LINH. On 11 May the 3rd Platoon Company D reinforced Company B L/W 9th Marines verbal instructions.

C. On 7 May the Battalion rear relieved 1st Battalion, 9th Marines as coordinator for ambushes in Sector I of the DONG HA Base Defense and assumed operational Control of CAC 1, 2, 3, and one platoon from D/1/9 at CAM LO Bridge. With the additional requirement it became necessary to activate another combat operation center under control of the Bravo Command Group.

D. At 0245H on 8 May companies A and D with the Alpha Command Group at CON THIEN came under an intensive 82mm mortar attack, followed by a ground attack from the east in Company D sector. Sapper units breached the wire under cover of the mortar barrage with bangalore torpedos and moved small units inside the wire. These small elements were heavily armed with satchel charges and TNT charges and used them to blow bunker and trench lines. At approximately 0400H, two battalions of NVN attacked the perimeter through the breach made by the sapper units. These NVN units were armed with flame throwers, RPG rocket launcher and various assortments of small arms, explosive etc. The attached engineer platoon was moved to reinforce Company D's right flank where the attack seemed to be centered. All 81mm illumination was utilized. Artillery illumination could not reach CON THIEN from their position at GIO LINH. A flareship arrived after some delay and provided illumination until daylight. Company A was directed to send a platoon reaction force to assist Company D as well as escort two LVT's and an

M-42 with ammo resupply. Enroute to Company D's right flank these vehicles came under fire and the M-42 and one LVTH were struck by RPG Rockets and set afire trapping several personnel inside. The other LVTH was set afire with a satchel charge. The penetration was limited and the breach in the perimeter was closed just prior to day light, cutting off the escape route of those enemy elements inside of the wire. By approximately 0900H all of these elements were either killed or captured. Tanks and LVTH-6's firing BEE HIVE and conventional ammo inflicted heavy enemy casualties both during the attack and during the withdrawal. The enemy was caught in the open crossing the recently cleared strip and provided an excellent target for direct fire weapons. After the area had been cleared of enemy stragglers and helicopters could land, evacuation of the friendly casualties began. The Battalion and supporting elements suffered 44 KIA's and 110 WIA's as a result of this attack. During the remainder of the day enemy bodies and equipment were collected. 226 enemy bodies were buried and covered by bulldozer. 8 NVA were captured and returned to DONG HA. 43 AK-47's, 19 RPG's, 2 flame throwers, 1 radio, 400 lbs explosive, and over 100 Chi Com grenades were collected in and around the perimeter. Company D was relieved in place by Company C late the afternoon of 8 May and returned to DONG HA and relieved 1/9 of SPARROW HAWK responsibility.

E. During period 9-21 May the units at CON THIEN (Now Companies A, C and Alpha Command Group) began receiving artillery fire daily from the north and northeast direction. Companies A, C and Command Group also received mortar fire from the east and South East. Resupply by helicopters and artillery and mortar fire so heavily the resupply had to be effected by aerial delivery. Engineer work on the clearing around CON THIEN was slowed considerable due to harrasing enemy artillery and mortar fire. The frequency of artillery fire increased almost daily through 17 May. On 12 May the Battalion Commander was wounded for the third time and evacuated. The Battalion XO took command of the Battalion. On 19 May Major R. C. BELL arrived and took command of the Battalion.

G. At 170001H May Operation HICKORY began after 1/9 made heavy contact approx 2000 yards south and south east of CON THIEN. This was a Multi-Battalion operation designed to clear the area around CON THIEN, of NVA elements. The Battalion's mission was to continue defense of CON THIEN, finish the cleared strip around CON THIEN outpost and be prepared to reinforce 1/9 on order.

H. At 211200H May the Battalion was relieved in place at CON THIEN by 1/9 and moved to vic YD 147617 to provide security for the 9th Marines Regimental forward CP and artillery battalion at that location.

I. On 29 May the Battalion was relieved in place by elements of 2/3 and return to DONG HA by convoy. Company B at GIO LINH was relieved in place by F Company 2/9 at 291300H. 2/9 relieved 1/4 (Rear) of base defense responsibility of SPARROW HAWK, OPCON of CAC units and the security platoon at CAM LO bridge.

J. On 30 May the Battalion chopped OPCON to the 4th Marine Regiment and began movement to the 4th Marines operating area vicinity of PHONG DIEN, RVN.

2. TRAINING. Due to the tactical commitments during the entire month no formal military training was conducted. Replacements assignments to the Battalion were briefed by the Battalion Executive Officer, drew and FAM fired M-16 rifles and were sent to the field to join their assigned units.

3. TRAINING PROBLEMS ENCOUNTERED. Due to the immediate need for replacements in the field it is felt that adequate familiarization, care and cleaning, etc of the M-16 rifle could not be given new replacements prior to joining their assigned units. Although this training would normally be accomplished prior to new replacements being assigned to units in the field, it was not possible to do so during May because of the immediate need for replacements for Rifle Companies in the field.

5. Supporting Forces. From 17 May 1967 to 28 May 1967 (Operation HICKORY) "D" Battery, 2nd Battalion, 12th Marines, was in direct support of 1st Battalion, 4th Marines. Reinforcing fires were delivered by the 175mm guns of the U.S. ARMY 94th Field Artillery Battalion and Battery "K", 4th Battalion 12th Marines. These batteries were very responsive to the fire requests sent by the forward observers with the companies. Counter mortar fires were delivered very quickly with results of three NVA Artillery pieces knocked out. Air observers were controlled directly by the Battalion FSCC and proved to be quite effective in spotting enemy gun positions and troop concentrations. All supporting fires were requested and controlled by Battalion FSCC.

a. Air Support. The majority of fixed wing aircraft missions were used in fire suppression of Artillery positions and other suspected positions. TPQ's were utilized in this role also, in addition to staging and assembly areas. The use of TACA proved invaluable for reconnaissance. Numerous Med-Evac missions were called as well as resupply missions when the tactical situation permitted. Support was provided by the First Marine Aircraft Wing.

## 6. INTELLIGENCE.

a. No enemy contact with enemy infantry units was made during the duration of the operation. Enemy activity consisted of Artillery, mortar, and recoilless rifle attacks upon the Battalion Defensive positions at CON THIEN (YD 114700).

Crater and fragmentation analysis determined that the enemy fire was of varied caliber, i.e. 82mm mortar, 76mm gun, 82mm RR, and 100mm gun (all of Soviet Design) and came from scattered positions in and across the DMZ.

### b. Terrain.

(1) Critical terrain features. These included the high ground at CON THIEN, strong point for friendly forces, Hill 56 (YD 114734) used by the enemy and Hill 48 also used by the enemy for mortar and RR attacks upon CON THIEN.

(2) Cover and Concealment. Thick undergrowth, heavy shrubbery; knee-high to man-high, and elephant grass offered good concealment. Underground cover and sand-bag bunkers were necessary due to lack of natural cover.

(3) Avenues of Approach. The main avenue of approach was a 10 kilometer dirt road from CAM LO to CON THIEN. Others were the fire break from CON THIEN to BHO LINH, and footpaths and trails interlocked in the area to the immediate south of the DMZ.

c. Weather. The start of the dry season influenced the weather in the operating area. Rising temperatures with humidity averaging 80%, were the norm for the reporting period. Visibility was good, with the exception of 3 or 4 days of haze. Cumulative rainfall was slight, though heavy rain of 1 or 2 hours duration occurred in the mid-afternoon.

7. MISSION. The mission of 1st Battalion, 4th Marines was to continue providing security for the Engineers clearing a 300 meter strip around CON THIEN to open a road to Rt 561 vic YD 137674, and reinforce 1st Bn 9th Marines on order.

8. Concept of Operation. Companies A, C and Alpha Command Group provide security for Engineer operations around CON THIEN and provide security for Engineer equipment building the road from CON THIEN to Rt 561. Be prepared and on order to provide reinforcements for 1/9. Company B remained OPCON to 12th Marines at GIO LINH Artillery complex. Company A remained at DONG HA and provided SPARROW HAWK and 1 platoon to reinforce Company B at GIO LINH. A rear COC was activated at DONG HA to control the CAC units and assist in perimeter defense.

9. EXECUTION. 9th Marine Operation Order 5-67 was issued and Operation HICKORY officially began at 170001H. On 17 May Co A provided security for Engineer elements cutting the road from CON THIEN to Rt 561. Little progress was made due to the close proximity of 1/9 elements moving toward CON THIEN. 1/9 was heavily engaged in the area 2000-3000 meters south of CON THIEN and receiving fire from the area between themselves and Company A. Therefore Company A pulled back to CON THIEN to allow supporting arms to fire in front of 1/9 elements. CON THIEN itself received 70-75 rounds of Artillery and mortar fire resulting in 2 FR/WIA Non-Evac.

On 18 May another attempt was made to continue building the road to Rt 561. One M-42 struck a mine and had to be towed back to CON THIEN. 6 WIA's were sustained, 2 of which were Med-Evaced. After some delay the road was completed to Rt 561 and a link-up was made at YD 137674 at approx 1600H with Engineers and 1/9 elements repairing the road from the south. A battery of artillery then moved to CON THIEN to further support operation HICKORY. No Enemy Artillery fire was received at CON THIEN outpost on 18 May.

On 19 May CON THIEN outpost received 28 rounds of enemy artillery fire from vic GS 1178 to 1278 throughout the day. Fire was returned at the enemy position with Artillery and Air Strikes. AO reports indicated 2 possible gun positions, were gun positions, and were destroyed by Artillery fire. No Friendly casualties resulted from Enemy Fire.

On 20 May CON THIEN outpost received 10-12 rounds Artillery and mortar fire. Counter battery fire was fired on suspected enemy gun positions. No Friendly casualties were sustained from enemy fire. The Battalion FSOC assisted in supporting 2/26 moving north across the cleared strip. Battalion 81mm mortars and attached tanks were used extensively as supporting and counter mortar fire for 2/26. 9th Marines Frag Order #4 was received directing 1/9 to relieve 1/4 on 21 May. 1/4 would move by convoy to 9th Marine FWD CP (vic YD 144617), assume OPCON of E/2/4, provide security for 9th Marine CP complex and become Division reserve.

On 21 May preparations were made to comply with 9th Marine Frag Order #4. Some delay was experienced in the process of relief and was not effected until 1300H. Approximately 10 rounds of mortar fire were received while effecting the relief resulting in 2 FR/WIA, 1 Med-Evac. Just prior to the convoy departing 10-12 rounds Artillery fire was received from the west resulting in 9 FR/WIA's. The convoy departed for

9th Marines CP at 1400H arriving approximately 1500H and assumed OPCON E/2/4. Companies A and C and Command Group Alpha tied in with E/2/4 and extended the present perimeter 600 meters to the west to include high ground at that location.

The battalion (-) remained in defensive position around the 9th Marines CP complex until operation HICKORY terminated at 282400H. E/2/4 chopped OPCON to 2/4 250800H and the battalion (-) moved inside the original perimeter. Companies established night ambushes, LP's and conducted day patrols around the perimeter. Daily requirements for road sweep security and convoy escort to CON THIEN outpost was also accomplished. Operation HICKORY ended at 282400H May and operation PRAIRIE IV continued.

10. RESULTS.

a. Friendly Losses.

(1) The following is a recapitulation of friendly casualties incurred by 1st Battalion, 4th Marines (Rein) during Operation HICKORY covering the period 17 May 1967 through 28 May 1967.

a. Supply techniques, Combat loads, ammunitions and weapons by assault troops.

(1) From 17 May until 22 May 1967 the battalion was operating on the GIO LINH - CON THIEN barrier strip. All resupply was delivered by air to that location. On 22 May Companies A and C plus the command group was deployed at the CAM LO area. Resupply to the CAM LO area was delivered by overland convey. No problem were encountered during this period.

(2) From 17 May until 22 May POL requirements comprised the bulk of weight lifted on resupply. POL resupply averaged 14,000 pounds per day and was delivered by helicopter. On 22 May the battalion moved its operating units to CAM LO and the POL requirement was deleted.

(3) All units carried the D/A of ammunition and no emergency resupply was needed during this period.

b. Maintenance. Third and fourth echelon maintenance was performed by FLSU, DONG HA. Spare Parts for LIWC's still remain a problem.

c. TREATMENT OF CASUALTIES AND EVACUATIONS AND HOSPITALIZATION.

(1) First echelon medical care was performed in the field by hospital corpsmen attached to the various line companies. Following field first aid, those patients requiring further care were evacuated via helicopter to the nearest available medical facility. The definitive treatment centers being: Delta Company, 3d Medical Battalion in DONG HA; Alpha Company, 3d Medical Battalion in PHU BAI; Naval Support Activity in DA NANG; the USS SANCTUARY AH-17 Hospital Ship and the USS REPOSE AH-16 Hospital Ship. In addition the Battalion Aid Station was utilized along with a "Forward BAS" for caring for patients with minor wounds.

(2) All casualties for this period were processed through definitive treatment centers. The Battalion Aid Station was not notified of the dispositions, treatment or conditions of the casualties medevaced to commands other than this command.

(3) There was one marine killed, five died of wounds, and thirty-five wounded in action from hostile fire reported. There was an additional five patients admitted to the Battalion Aid Station Ward for non-combat treatment.

(4) The Battalion Aid Station Ward having 10 beds was utilized for patients not requiring intensive care. Those patients released from the various medical facilities were treated daily at the Battalion Aid Station and returned to duty as soon as possible.

(5) There were 344 patients seen at sick call. Twelve (12) non-combat injuries; two (2) combat injuries were evaced to BAS during this period. There was one patient from Golf Battery 3/12 and one patient from the U. S. ARMY treated during this period.

7. There were no cases of Malaria, Scrub Typhus or other significant infectious encountered.

d. TRANSPORTATION. Transportation was provided by ninth Motor Transport Battalion and HMM 363. Transportation requirements were met satisfactorily through out the entire period.

e. COMMUNICATIONS. Communications were generally satisfactory through out operation HICKORY. There was some slight unintentional interference in the late afternoon on FM nets. KY-8 operations remained continuous.

(1) Two radio nets remained activated during HICKORY. Battalion TAC #2, provided internal radio communications and Regimental Tac #1, linked the Battalion with Regiment.

(2) External wire communications provided continuous operation into the third Marine Division/Third MAF Telephone system. Internal wire communications were established at all CP locations.

## 12. SPECIAL EQUIPMENT AND TECHNIQUES.

During the operation a AN/TPS-21 was placed on high ground at the CON THIEN outpost. A sandbag emplacement was built high around the antenna leaving adequate room to operate and still furnish maximum protection from enemy artillery and mortar fragments. The operators were placed a short distance away in a CONEX box, dug into the ground and heavily sand bagged.

On several occasions the AN/TPS-21 detected enemy movement along the cleared strip east of CON THIEN outpost. 81mm mortar and artillery fire was immediately brought to bear on the enemy resulting, in possible casualties. In all cases, the screen indicated no further detection of the enemy moving out of the area. The AN/TPS-21 proved invaluable during this period.

13. COMMANDERS ANALYSIS

a. On 12 May the battalion rear was required to relieve 1/9 of perimeter defense responsibility and take control of the CAC units and the platoon at the CAM LO bridge. This requirement necessitated opening another COC in the rear and manning four more radio nets. This placed a heavy burden on radios and other comm equipment. In addition the rear COC was responsible for coordinating two ambushes in one sector of the perimeter. All other activities in the perimeter were coordinated by the 9th Marine COC.

b. The splitting of responsibility for activities outside the base perimeter created a coordination problem involving those activities.

c. The fact that the rear COC had no FSCC or air team available caused undue delay in requesting supporting fires for the CAC units, because of the many agencies these requests had to be routed through before approval. (ie: 45 Minutes for illumination)

14. RECOMMENDATION:

a. The control and coordination of a base defense be centralized. Due to its very nature, the many units involved and the coordination requested, the base defense role should be controlled by only one agency.

b. The small size of forces occupying CAC compounds require instant supporting fires. Appropriate communications equipment should be made available to such units to enable direct contact with their supporting arms agency or control agency with the capability of clearing and assigning a supporting element.

a. Artillery. "D" Battery 2nd Battalion, 12th Marines was placed in direct support of this battalion for the period covered with this report. This battery was very responsive to the fire requests from the forward observers with the companies. Reinforcing fires were available from the 175mm guns of the U.S. ARMY 94th Field Artillery Battalion. Communications were good throughout the period covered with no time lost for relaying fire missions. Heavy volumes of day and night H&I's were fired and prep fires were used extensively. Counter mortar fires were delivered quickly with the result that no mortar attack lasted longer than 5 minutes. FSCC was in the field and requested and controlled these fires.

b. Air Support. The First Marine Aircraft Wing provided air support for the period covered. Helicopter support was used extensively for resupply Med-Evacs, reconnaissance and miscellaneous. Fixed wing aircraft were requested for CAS and TPQ's. Requests were sent in by the FAC teams to the Battalion COC which relayed to the controlling agency. Med-Evac requests were handled in the same manner.

6. Intelligence.

a. Enemy situation in the Battalion Operating Area.

(1) The enemy encountered in the GIO LINH - CON THIEN area was NVA. The enemy infantry units were regular line infantry, equipped with AK-47 assault rifles, SKS carbines, RPD IMG, B-40 (RPG) rocket launchers and Chi Com Grenades. These units were reinforced with sapper units, whose mission was to breach defensive wire with satchel charges to make way for the assault forces. Transportation units were attached to move casualties to the enemy's rear. Fire support was provided by 60mm and 82mm mortars and 82mm RR (Model B-10). During the 8 May attack on CON THIEN, intelligence sources stated that the wounded NVA were transported to a hospital at AN NHA (YD 123725). Besides NVA infantry, North Vietnamese artillery (suspected 76mm and 100mm) was used to shell CON THIEN almost daily (receiving from 20 to 60 rounds a day).

Interrogation of NVA POW's, captured 8 May at CON THIEN, identified the enemy units which attacked CON THIEN as 4th Bn 812 Regt, 324 B NVA Div; 6th Bn, 812 Regt, 324B NVA Div (AKA THU Bn or B. VI Regt).

b. Terrain.

(1) Critical Terrain Features. These included the high ground at CON THIEN (YD 114792) strong point for friendly forces, hills 56 (YD 140733) and 48 (YD 114734) used by the enemy for mortar and ML attacks upon CON THIEN.

(2) Cover and Concealment. Thick undergrowth, heavy shrubbery; knee-high to man-high, and elephant grass offered good concealment. Underground cover and sandbag bunkers were necessary due to lack of natural cover.

(3) Avenues of Approach. The main avenue of approach was a 10 kilometer dirt road from GAM LO to CON THIEN. Others were the fire break from GIO LINH to CON THIEN, and footpaths and trails interlaced in the area to the immediate south of the DMZ.

c. Weather. The start of the dry season influenced the weather in the operating area. Rising temperatures with humidity averaging 80%, were the norm for the reporting period. Visibility was good with the exception of 3 or 4 days of haze. Cumulative rainfall was slight, though heavy rain of 1 or 2 hours duration occurred in the mid. afternoon.

d. Enemy Personnel and Equipment Losses.

e. Items of Significant Intelligence Value.

(1) On 10 May, the 2nd platoon of Company A located a guidance section of a Russian built SA-2 (SAM) missile. It was recovered and forwarded to higher headquarters for analysis.

7. MISSION. Continue constructing a 200 meter wide strip cleared of all vegetation from GIO LINH to CON THIEN; provide security for engineer equipment; and clear enemy elements from around the strip area. Upon arrival, CON THIEN perform necessary maintenance of equipment then clear a 300 meter wide strip of all vegetation around the perimeter at CON THIEN.

8. Concept of Operation. Companies A, C, D and Alpha Command Group with attached supporting elements provide security and control headquarters for the construction of a 200 meter strip from GIO LINH to CON THIEN. Conduct patrols to flank and front to locate and destroy enemy forces, equipment and supplies.

9. Execution. Companies A, C, D and Alpha Command Group continued providing security and control of 200 meter wide strip. At the point the strip was approx 50% completed, Company B remained at GIO LINH under OPCON 12th Marines.

At 211200H April, 1st Bn 4th Marines Bravo Command Group was relieved of perimeter defense responsibility at DONG H. by 1st Bn 9th Marines. During the day of 21 April Company D patrols discovered

72 rounds of 82mm ammo at YD 174716 and YD 156716. Two Chi Com carbines, 2 cartridge belts, 3 Chi Com grenades were found at YD 165715 and returned to battalion S-2.

On 22 April the lead truck of a convoy moving down the strip from GIO LINH detonated a mine causing extensive damage to the truck and 1 FR/WIA. The area had been swept prior to the convoy entering the area.

At 221300H Company C received moderate S/A fire and several rounds mortar fire at YD 145725 from unknown size enemy force. Company C returned fire and called Arty. Swept area and found 2 NVs/KIA (C). Company C sustained 9 FR/WIA's.

At 221430H Company A unit received heavy S/A fire, 15 rds RPG rocket fire and 7 Chi Com grenades from YD 145719. Returned fire with S/A and M-79 rds. Swept area and found 2 NVs/KIA (C), 1 Chi Com rifle and one RPG rocket launcher with ammo. Company A sustained 2 minor WIA's.

At 221545H a tank moving in vic YD 151718 hit a mine blowing off a track. Company A was passing through elements of C Company in the vic of the tank and both companies received 15 WIA's from shrapnel, 9 of which were Med-evaced.

At 231215H a Company A unit discovered a cache of 45 82mm mortar rounds under the floor of a hut. All were destroyed in place.

At 231345H Company D moved to CON THIEN outpost to occupy the portion of the perimeter vacated by an ARVN unit. This left only Company A and C to provide security for the engineer effort.

At 231645H another tank hit a mine at YD 181731 while escorting a damaged tank back to the GIO LINH artillery complex. The tank was repaired and continued to GIO LINH.

At 241400H a Company C unit discovered 14 graves approx 2 - 3 days old containing one NVs body each at YD 144723. This discovery was believed to be the results of the company C contact in that area on 22 April. Company A found 48 graves at YD 156712, 2 of which contained 4 NVs bodies and 46 containing 2 bodies each a total of 104 bodies. All were wearing khaki uniforms and had been dead for 3 or 4 weeks. Some graves had markers with a man's name, date of death and unit. Grave markers were returned to Bn S-2 and forwarded to 9th Marines S-2. This discovery believed to be a result of operation BLACK HILL I 20 - 30 March 1967.

At 241500H the scattered wreckage of a F4B aircraft was discovered near the Bn CP vic YD 158719. Further search of area revealed a burned ID card and dog tags, parts of 2 life vests and parts of a human body. This was believed to be a plane shot down in that area on 13 March 1967. All personal items were forwarded to 9th Marines S-1.

By 25 April the 200 meter wide strip was 70% complete and no enemy contact was made during the day.

At 260700H the Bn CP received 4 rounds 155mm friendly artillery sustaining 1 Fw/KIA (USA) and 11 WIA's of which 6 were Med-evaced. The Battalion Commander, Lt Col. T. J. WILLIS was also wounded and Med-evaced. The Battalion Executive Officer moved to the field immediately and assumed command of the Battalion.

At 261245H the Battalion assumed OPCON of the 3d Co, 3d Bn, 2d ARVN Regt, 1st ARVN Div. This unit was given a portion of the perimeter defense for the night.

At 262110H Company D on CON THIEN outpost received sporadic S/A fire from the north. Returned fire with S/A and 81mm mortars. No Casualties.

On 27 April the ARVN company was moved back to vic YD 197734 to provide security for the tower being installed on the strip. The Battalion sent a liaison team with them for control and communications. The ARVN unit chopped OPCON back to its parent unit on 28 April and the liaison team returned to the Battalion.

At 271030H Company C received S/A and 60mm mortar fire at YD 154716. Fire was returned with 81mm and artillery. Company C assaulted the enemy position finding 3 NVA/KIA (C). The Company sustained 1 KIA, 12 WIA's, 7 of which were Med-evaced.

At approximately 1815H the Battalion CP witnessed GIO LINH artillery positions receiving artillery fire from across the DMZ.

At 272010H the 1/4 Fwd CP received 30 - 40 rounds 82mm mortar fire. Fire was returned immediately with 82mm mortars. Mortar fire ceased. 17 WIA's were sustained, 4 of which were evaced. One of the Med-Evac helicopters crashed while attempting to land in the LZ. The crew was not injured and remained at the CP overnight.

On 28 April six more bulldozers were sent out from GIO LINH. The 3d platoon Company A provided security for their movement down the strip to the engineer work area arriving at 1630H.

At 282015H Company D on CON THIEN received approx 30 rounds mortar fire from vic YD 112720. Fire was immediately returned with 81mm and artillery. Mortar ceased. No friendly casualties.

By 29 April the 200 meter wide cleared strip from GIO LINH to CON THIEN was 90% completed.

At 311050H the GIO LINH - CON THIEN strip was completed. Company A and part of the command group returned to DONG HA. Company C and a small command group remained to provide security for equipment.

From 31 April - 03 May preventative maintenance was performed on all equipment in preparation for further operations. Some vehicle

and equipment crews were exchanged during this period. Some vehicles were moved to GIO LINH via the strip and exchanged there and returned to CON THIEN. Company C provided security for this movement.

On 4 May the Engineers began clearing a 300 meter wide strip around CON THIEN.

On 5 May Company A returned to CON THIEN to relieve Company C which returned to DONG HA. Work continued on the 300 meter wide strip around CON THIEN. Some booby trapped grenades left by ARVN units were encountered and destroyed. Sporadic 82mm mortar fire was experienced during this period. SEABEES began installing look out towers along the strip starting from GIO LINH.

At 0245H on 8 May companies A and D with the Alpha Command Group at CON THIEN came under an intensive 82mm mortar attack, followed by a ground attack from the east in Company D sector. Sapper units breached the wire under cover of a mortar barrage with bangalore torpedos and moved small units inside the wire. These small elements were heavily armed with satchel charges and TNT charges and used them to blow bunkers and trench lines. At approximately 0400H, two battalions of NVN attacked the perimeter through the breach made by the sapper units armed with flame throwers, RPG Rocket launcher and various assortments of small arms, explosives, etc. The attached engineer platoon was moved to reinforce Company D's right flank where the attack seemed to be centered. All 81mm illumination was utilized. Artillery illumination could not reach CON THIEN from their position at GIO LINH. A flareship arrived after some delay and provided illumination until daylight. Company A was directed to send a platoon reaction force to assist Company D as well as escort two LVT's and two M-42's with ammo resupply. Enroute to Company D's right flank the right rear sprocket of the leading LVT became enmeshed in barbed wire, freezing and stopping the vehicle. The vehicle came under fire and the M-42's and one LVTH were struck by RPG rockets and set afire trapping personnel inside. The other LVTH was set afire with a satchel charge. The penetration was limited and the breach in the perimeter was closed just prior to daylight, cutting off the escape route of those enemy elements inside of the wire. By approximately 0900H all of these elements were either killed or captured. Tanks and LVTH-6's firing BAE HIVE and conventional ammo inflicted heavy enemy casualties both during the attack and during the withdrawal. The enemy was caught in the open crossing the recently cleared strip and provided an excellent target for direct fire weapons. After the area had been cleared of enemy stragglers and helicopters could land, evacuation of the friendly casualties began. The battalion and supporting elements suffered 44 KIA's and 110 WIA's as a result of this attack. During the remainder of the day enemy bodies and equipment were collected. 226 enemy bodies were buried and covered by bulldozers. 8 NVN were captured and returned to DONG HA. 43 AK-47, 19 RPG rockets, 2 flame throwers, 1 radio, 400 lbs of explosive, and over 100 Chi Com grenades were collected in and around the perimeter. Company D was relieved in place by Company C late the afternoon of 8 May and returned to DONG HA and relieved 1/9 as SPARROW HAWK responsibility.

At 082010H a fire at one of the towers on the strip was observed and at 082030H an explosion was observed in the vicinity of another

Tower. Company B at GIO LINH confirmed that one of the towers was being burned. On 9 May an AO reported that 3 towers were down and only the tower nearest GIO LINH was standing.

At approximately 102100H the FID CP observed what appeared to be a (SAM) missile strike at a TPQ aircraft northwest of CON THIEN. The aircraft exploded and crashed. At 1400H on 11 April a large object was found by a Company A patrol at YD 103683 believed to be part of a SAM missile. The object was helo lifted to DONG HA.

At 111500H a NUNG patrol wic YD 135710 began receiving 82mm mortar fire and made contact with an estimated Company of NVA. The patrol quickly withdrew to the CON THIEN perimeter under cover of 81mm mortar and artillery fire. CON THIEN outpost received 40 - 50 rounds 82mm mortar fire sustaining 4 WIA non-evac. Five mortar positions were spotted by an AO and called an air strike destroying all five positions. At 1700H CON THIEN received 35 - 40 82mm rounds of mortar fire sustaining 1 WIA, non-evac.

At 121600H the rear COC opened and assumed OPCON of CAC 1, 2, 3, and a platoon security at CIM LO bridge.

From 121530H - 121605H CON THIEN received 25 - 30 rounds 82mm mortar fire resulting in 1 KIA and 10 WIA's. Lt Col. MILLIS, the Battalion Commander, was wounded for the third time and evacuated. The Battalion Executive Officer assumed Command of the Battalion in the field.

At 121655H a resupply helicopter was struck by a recoilless rifle in mid air. The helicopter crashed and burned. Two crew members were WIA and 2 were MIA presumed to be in the wreckage. On the morning of 13 May the wreckage was searched and the two MIA's were found. The bodies were hardly identifiable due to the intense heat of the burning helicopter. The bodies were evacuated to D-med for identification.

During the day of 13 May the CON THIEN outpost received a total of 93 rounds of artillery and mortar fire resulting in 1 KIA and 13 WIA's. The new Battalion Commander Major R. C. BELL took command of the battalion in the field. One LVTP-5 received a direct hit from an artillery round at 0830H resulting in 1 KIA and 2 WIA. The LVTP-5 was damaged but still operable.

CON THIEN outpost received 45 rounds of mortar and artillery fire during the day of 14 May resulting in 7 WIA's non-evac.

At 142100H an ambush patrol departed GIO LINH artillery position became lost while moving through the mine field around the perimeter. One man stepped on a mine resulting in 1 FR/KIA and 2 WIA's med-evac.

At 150305H CAC-3 came under heavy mortar and satchel charge attack by approximately 2 platoons of VC. Five penetrated the defensive wire and blew an ammo bunker. At 0330H the VC withdrew. Sporadic S/A fire continued on CAC-3 and the PF's at the bridge at YD 182588 until approximately 0515H. Artillery fire was called on suspected enemy mortar positions and enemy withdrawal routes. Casualties were evacuated at

0545H after several tries. Results of this action was, 1 FR/KIA, 15 FR/WIA 4 of which were evaced. In addition 3 PF's were KIA's, and 1 PF MIA, 1 civilian WIA, and 6 KIA's. One VC KIA was found on the defensive wire and the villagers said the VC carried approximately 25 dead or wounded VC through the village on their withdrawal.

During the day of 15 May the CON THIEN outpost received a total of 96 rounds of Artillery and Recoilless rifle fire resulting in 2 WIA's one of which was med-evaced. This harrassing fire was fired in volleys from 4 - 30 rounds each sporadically throughout the day.

During the day of 16 May the CON THIEN outpost received 60 rounds of Artillery and Recoilless Rifle fire sporadically in volleys from 4 - 15 rounds resulting in 6 WIA's; two were med-evaced.

At 170001H the battalion began operation HICKORY LAW 9th Marines operation Order 5 - 67.

At 282400H the battalion terminated operation HICKORY and continued PRAIRIE IV at 290001H. The battalion was providing security for the 9th Marines CP complex at YD 147614. At 1300H on 30 April the battalion was relieved by 2/3 and returned to DONG HA.

At 300900H the battalion was relieved of the defense responsibilities at DONG HA by 2/9 and prepared to move to CO BI THANH TAIN. PRAIRIE IV terminated for the battalion 300900H.

10. Results.

a. Friendly Losses.

(1) The following is a recapitulation of friendly casualties incurred by the 1st Battalion 4th Marines (Rein) during Operation PRAIRIE IV covering the period 20 April 1967 through 16 May 1967 and 29 May 1967 through 30 May 1967.

11. Treatment of casualties and Evacuations and Hospitalization.

First echelon medical care was performed in the field by hospital corpsman attached to the various line companies. Following field first aid, those patients requiring further care were evacuated via

helicopter to the nearest available medical facility. The definitive treatment centers being: 3d Medical Battalion, Delta Company and Alpha Company; Naval Support Activity in DA NANG; the USS SANCTUARY AH-17 Hospital Ship and the USS REPOSE AH-16 Hospital Ship. In addition the Battalion Aid Station was utilized along with a "Forward BAS" which included a medical officer for caring for patients with minor wounds.

All casualties for this period were processed through definitive treatment centers. The Battalion Aid Station was not notified of the dispositions, treatment or conditions of the casualties medevaced to commands other than this command.

There were 39 Marines killed, two (2) hospital corpsmen killed and 207 wounded in action from hostile fire reported. One Marine died of wounds.

The Battalion Aid Station Ward having 10 beds was utilized for patients not requiring intensive care. Those patients released from the various medical facilities were treated daily at the Battalion Aid Station and returned to duty as soon as possible.

There were 857 patients seen at sick call. Thirty non-combat injuries and fifty-six combat injuries were evaced to BAS during this period. There were two patients from Golf Battery 3/12 treated at Battalion Aid Station during this period.

There were no cases of Malaria, Scrub Typhus or other significant infections encountered.

12. Administrative Matters. The administrative concept was that units operating in the GIO LINH - CON THIEN barrier strip area would request resupply through the S-4 representative at the forward area. The S-4 would forward these requests to the LSA DONG HA, via the HST resupply net. Supplies were then collected and staged for helicopter delivery at the LSA helicopter pad by the battalion supply section. The use of the HST resupply net for administrative traffic prevented the battalion tactical net from being overloaded.

a. Supply techniques, combat loads, ammunitions and weapons Carried by Assault Troops.

(1) All resupply for the units operating in the GIO LINH CON THIEN barrier strip area were resupplied by helicopter lift. On two occasions parachute air drops were performed by C130 aircraft but this was discontinued due to heavy and effective enemy fire. The planes took extensive small arms hits. Due to extensive artillery fires on the LZ helicopters would not land but performed ramp drops.

(2) The logistical requirements during this period required large amounts of POL due to the engineer type task force operation. POL using vehicles consisted of 28 Bulldozers, 4-M-42's dual 40mm vehicles, 5 tanks M48A3, 1 LVTG, 6 LVIP-5, 2 LVH-6, 6 LIWC, and 1 M109. The POL resupply averaged 14,000 pounds per day.

(3) All units operating on the GIO LINH - CON THIEN barrier strip carried the full B/A. On 8 May due to a prolonged action part of the B/A was expended by the entire task force and a emergency resupply request was delivered. This emergency resupply was a complete B/A and weighed 92,000 pounds.

b. Maintenance. Third and fourth echelon maintenance was performed by FLSU, DONG HA. Due to the lack of spare parts at FLSU, the battalions LIWC's are remaining in 3rd echelon repair for long periods of time.

c. Communications. Communications were satisfactory throughout PRAIRIE IV. Some difficulty was experienced due to the close proximities of radio nets operating on frequencies unavoidable too close to each other within the FSCC and other unintentional interferences occurred usually during increased periods of activity but little could be done to alleviate the problem without an administrative net. KY-8 closed voice circuit was employed extensively with excellent results. (and the introduction of TPS-21 radar equipment proved highly successful along the strip between GIO LINH and CON THIEN)

(1) Five radio nets were activated during PRAIRIE IV: Battalion TAC #2, provided internal radio communications, regimental TAC #1, linked the Battalion with Regiment, the Sector Defense net which later was changed to the next higher echelon, the perimeter Defense Net was used for local security of DONG HA Combat Base and the CAC force Control net for establishing coordination between DONG HA CAC forces under our operational control.

(2) External wire communications provided continuous operation within the Third Marine Division/Third MAF Telephone system. Internal wire communications were established at all CP Locations.

12. Special Equipment and Techniques. NONE

13. Commanders Analysis. All forms of combat support and combat service support were effective throughout the period and assigned missions and tasks were accomplished. When one Company was attached to provide security for GIC LINH and it became necessary to move one to CON THIEN, the remaining companies were hard pressed to field sufficient patrols and ambushes while providing security for the engineer effort.

14. Recommendation. On similar situations where a battalion is operating independently and the enemy has the capability to mass large numbers of troops, it is recommended that not less than three rifle companies of the battalion be employed in support of engineer elements.

## LOGISTICS

1. Logistical Situation. During the period from 1 May to 30 May the Battalion was based at DONG HA Combat Base. Company B was deployed at the GIO LINH area for the entire period and was OPCON, 12th Marines. Company D was located at CON THIEN from 1 to 8 May and at DONG HA the remaining period and from 8 to 30 May Company D provided the reaction Company and Sparrow Hawk. From 1 to 5 May Company A was at DONG HA and from 5 to 21 May they were at CON THIEN. Company C was at CON THIEN from 1 to 5 May, at DONG H A from 5 to 8 May and then returned to CON THIEN. On 21 May, Companies A and C with Command Group Alpha, moved to CAM LO area and remained there until 29 May. At this time the entire battalion returned to DONG HA to prepare for a move to the CHOCTAW area. On 30 May the Battalion moved by convoy to the CHOCTAW area.

2. Supply. Resupply for the CON THIEN area averaged 15 tons daily from 1 to 21 May. After 21 May the attached engineer units required less fuel and the resupply averaged 13 tons.

a. Class I. 40,500 Meals, Combat, Individual, and 18,000 gallons of water were distributed during the period. "Alpha" rations were furnished the battalion and delivered for the evening meal on 15 occasions.

b. Class II. Supplies were issued as appropriate. 800 pair socks were issued but medium size socks were not available. 400 sets of jungle utilities were issued but small size were seldom in stock. Undershirts and underdrawers were in short supply. Bath towels were NIS for the entire period.

c. Class III. 30,000 gallons of diesel fuel, 6,000 gallons of MORGAS, 440 gallons OE-30 weight lube oil, 165 gallons OE-10 weight lube oil and 750 pounds of GAA-3 grease were provided. Bore cleaner and gun oil were in short supply.

d. Class IV. 140 rolls of concertina, 550 rolls of single strand barbed wire, 800 five foot stakes, 364 thirty-two inch stakes, and 45,000 sand bags were expended and used on defensive positions.

5. Miscellaneous. During this reporting period all resupply was performed by the LSA DONG HA. A great improvement was noticed in water resupply when 500 gallon external lift bladders were used to supplement five gallon water cans.

## COMMUNICATIONS-ELECTRONICS

## SECTION VI.

1. General. This report covers the period 1 through 31 May 67. The entire period was devoted to support of battalion operations, maintenance of equipment and training of new personnel. There was extensive use of KY-8 covered circuit voice communications and TPS-21 radar.

2. Operations. Communications was generally satisfactory throughout this period. There was some intermittent interference on the battalion and company TAC nets.

a. On 6 May a TPS-21 radar set was installed at Gio Linh to detect enemy movement along the fire break and western end of the perimeter. On 13 May another TPS-21 was installed at Con Thien with the similar mission, thus completing coverage of the strip. From 6 May to 16 May, eight artillery missions were called as a result of detection by the radar set at Gio Linh. Since 16 May no missions have been credited to this site due to generator problems and lessening of activity on the strip. From 13 May to 19 May, six artillery missions were called by the radar set at Con Thien. On 20 May this set was removed when the battalion forward CP displaced to Cam Lo.

b. On 7 May SSgt Smith, Message Center Chief, rotated to CONUS. CSM Chambers is now the acting Message Center Chief.

c. On 8 May combat losses resulted in three PRC-25's and two receiver-transmitters being code "X"ed, and numerous accessories were destroyed these were the result of the enemy engagement at Con Thien.

d. On 12 May the battalion resumed the perimeter Defense responsibility from 1st Battalion 9th Marines. In addition to the battalion and regimental nets, the perimeter nets, Sector Defense net and CAC forces were utilized to provide communications for this requirement.

e. On 16 May Shave forward assumed control of Dong Ha Combat Base. The 9th Marine Regiment switchboard was changed to Division Forward.

f. On 17 May a switchboard was installed at battalion forward Con Thien linking FSCG Command with "A" Co., "C" Co., 11th Engrs., Special Forces and the radar unit. Traffic became heavy on Regimental TAC #2 so TAC #1 was also activated for overflow. Operation Hickory began at 170001 H.

g. On 18 May a new COI extract was distributed.

h. On 21 May CP site moved to Cam Lo. Radio Communications was continuous with all stations. Switchboard installed with trunk line to 9th Marines.

i. On 29 May 9th Marines resumed control of Dong Ha Combat Base. The Battalion Comm Officer and Headquarters Commandant displaced forward to 4th Marines area to select CP site.

j. On 30 May 1st Battalion 4th Marines displaced to 4th Marine area, 2/9 assumed control of Perimeter Defence for Dong Ha. OCC bunker put into operation with FM communications linking with regiment and hot line installed.

1. Message center operation was normal for the period. In the Dong Ha perimeter, incoming message traffic was guarded for the battalion by 3rd Mar Div Forward or 9th Marine Regiment. On the 30th of the month, the message guard was transferred to 4th Marines. Distribution of numerical and authentication codes were effected from the rear OP to the user. Message totals were:

Air activity in support of the 1st Battalion, 4th Marines operations was widely varied and extensive during the period of this report. On 1 May 1967 the GIO LINH - CON THIEN firebreak was completed and during the period 2 May to 7 May units were helolifted to the DONG HA Combat Base for short periods in the rear and returned to CON THIEN. During the night attack on CON THIEN outpost during the pre dawn hours of 8 May flare ships were extensively utilized to illuminate the battle field. On the morning of 8 May, 43 Marine Med-evac sorties were flown and close air support aircraft caught approximately 200 of the fleeing attackers in the open with devastating results. Helicopter resupply throughout the period was extensive with the normal daily lift averaging in excess of 10 tons.

On 13 May 1967 the first combat air drop resupply of Marines by Marine KC-130F aircraft of the Vietnamese conflict was made to this units elements at CON THIEN. This was necessitated by excessive hostile fire which covered the helicopter landing zone ruling out normal helicopter resupply. The drops were a complete success and 100% on target with 95% of the resupply recovered undamaged.

9. Weekly administration of Chloroquine-Primaquine Anti-Malarial prophylaxis tablets were continued throughout this month.

10. H & S Company, Alpha Company and Delta Company received all necessary immunizations, in accordance with BUMEDINST 6230 series. 122 personnel were completely immunized for leave, Rest and Recreation and return to CONUS. NOTE: No influenza immunizations were administered.

11. There were 16 laboratory procedures performed at the Battalion Aid Station during the month. These included two Gram Stains for gonorrhoea (one positive and one negative), eight urinalysis, four RPR Card tests and two CBC's.

12. There are no patients on the Battalion Aid Station Ward and there are four men on Light, Limited or No Duty at this time.

13. Four sanitation inspections were held according to DivO P6000.4D in the Battalion area and action initiated on all noted discrepancies. An inspection was held by the Division Sanitation Team on all water containers in the battalion area on 20 May 1967, action was taken on all discrepancies.

14. In addition to providing medical treatment, Battalion Aid Station personnel were also involved in building two large bunkers for treating and protecting patients during enemy attack. Medical aid was supplied to D Company, Third Medical Battalion on 8 May and 9 May when a large influx of 1st Battalion, 4th Marine casualties were treated by that facility.

## SECTION X

Civil Affairs for this reporting period consisted of two solatium payments and two civilian med-evacs. The solatium payments were made as a result of friendly Artillery fire which killed six civilians and destroyed one home. A total of 2400 \$VN were paid to two individuals in an effort to express our sympathy at their losses. The Med-evacs came when our troops located two civilians on different occasions who had suffered serious wounds, cause unknown. Both taken to QUANG TRI via helicopter for treatment. Also Medcap supplies were requested for our medcap programs with a small number of supplies coming through. More Civil Affairs were curtailed because of combat operations.

In the field of Psychological Warfare the main effort was in leaflet drops used to exploit our victory at CON THIEN. The main theme in these drops were for CHIEN HOI, rewards for NVA equipment, and warning civilians not to aid the VC, and to show our complete victory, over the NVA who attacked CON THIEN.
