PART IINARRATIVE SUMMARY1. PERSONNEL AND ADMINISTRATION

a. Strength. The battalion strength at the beginning of the month was 42 officers and 1228 enlisted. By mid-month the strength had dropped to 38 officers and 1132 enlisted, with 7 officers and over 400 enlisted hospitalized. These casualties were due primarily to Operation "HUE CITY" in which the Battalion participated. On 29 February 1968 the Battalion strength was 37 officers and 1249 enlisted, including 5 officers and 400 enlisted hospitalized. Replacements and additions numbered 13 officers and 382 enlisted.

b. Discipline, Law and Legal. During the month of February there were no courts-martial processed. One Article 32 Investigation was conducted and three investigations completed.

c. POW/Detainees. No POW were processed during the month of February.

d. Morale and Personal Services. Morale throughout the Battalion remained commendably high despite casualties suffered during Operation "HUE CITY." The men and officers of this Battalion who were actively committed to the Battle for Hue returned with that sense of pride and accomplishment reminiscent of past victories and achievements of this Battalion.

e. Postal. Postal service for personnel of the Battalion deteriorated during the month of February due to lack of qualified personnel for the Battalion Mail Room. This was caused by one postal clerk being wounded in action and medically evacuated and the other being on special leave.

A new postal clerk was given instructions and placed on the job training as a postal clerk. While on Operation "HUE CITY" mail was delivered regularly to personnel in the field.

f. Awards. After movement of the Battalion Rear to Phu Bai, the Regimental Commander presented one Silver Star and three Bronze Star Awards to members of this command at a battalion formation.

g. Interior Management. On 12 February 1968 the Battalion S-1 moved from Phu Loc, RVN to Phu Bai, RVN where it is presently located. The move required one day's time and administration continued with little time lost.

2. ENEMY, WEATHER AND TERRAIN.a. Enemy.

(1) Activities. A very sharp rise of enemy initiated

incidents to include platoon/company size engagements characterized enemy efforts early in this reporting period. At 010210H, CAP H5 and the Battalion Assembly Area came under heavy mortar fire. In addition, CAP H5 was assaulted by a ground attack with the enemy utilizing grenadiers, B-40 rocket squads and automatic and semi-automatic weapons gaining control of CAP H5 and Phu Loc village. In the early morning hours, Company A received approximately 15 B-40 rocket rounds along with automatic and semi-automatic weapons fire while set in its night position. Company B received 45-50 rocket rounds and heavy small arms fire while at Phu Loc District Headquarters on 1 February. Blocking forces from the Battalion Assembly Area were sent to block enemy movement to the south from Phu Loc with reaction forces moving into Phu Loc to regain CAP H5. All met with stiff resistance from the enemy in the village upon securing CAP H5. The Battalion Assembly Area and units in the Phu Loc vicinity received sporadic mortar fire throughout the day.

Enemy resistance remained scattered throughout 2 February. Units near and within Phu Loc and the Battalion Assembly Area continued to receive sporadic mortar fire. During the early afternoon of 3 February Company D came under heavy fire from an estimated reinforced VC/NVA company on high ground while moving west along the MSR at (ZD 197009). After fighting stiff resistance, Company D maneuvered out of the area prior to the ambush being tightened. On 4 February Company A and Company B moved toward the area from the west and made contact with remnants of approximately 200 hard corps VC that had fled south upon the approach of friendly troops. Company B pursued the fleeing enemy as artillery fired blocking fires and a HULE gunship checked the area. Company D on the east met with stiff resistance at Thua Luu from an estimated company size enemy force holding high ground to both flanks at (ZD 198010), (ZD 205007) and (ZD 206011). The enemy could be heard using whistles to maneuver elements to cut off withdrawal routes as they used snipers, mortars and Claymore type mines against friendly lead elements. Company D maneuvered to a blocking position outside the ambush area supported by Naval Gunfire and artillery. Intelligence reports revealed the enemy moved out of the area to the south under the cover of darkness utilizing the villagers to carry their wounded.

On 7 February Company B came in frequent contact with the enemy during the day from (YD 967057), (YD 967053) and (YD 965057) as Company B participated in a battalion size operation in the vicinity of the Truoi River Bridge. The enemy utilized 60mm mortars, rockets, automatic and semi-automatic weapons from dug-in and entrenched positions. Enemy fire was suppressed

by return fire, artillery and air support as the company continued the attack. On 9 February a two-company reconnaissance in the area southeast of the Battalion Assembly Area received mortar fire from (ZC 102977). 3rd Platoon, Company A in the area of the mortar fire maneuvered toward it and received small arms, rocket and mortar fire. A search of the area resulted in numerous blood trails being found in the vicinity of earlier prep fires. A large amount of communications wire was found in the immediate area indicating an extensive land line communication network. Further search revealed the enemy apparently fled south over the ridgeline.

During the reporting period the enemy continued to set ambushes, mines and booby traps along the MSR. On 4 February a bridge was found destroyed at (ZD 129012) and three anti-vehicular mines were found buried one-half inch below the dirt where the road had been damaged at (ZD 118016), (ZD 122066) and (ZD 125013). On 5 February 40 to 50 pounds of TNT were command-detonated along the side of the road at (AU 805008) as Company D moved along the MSR. On 6 February a Mine Sweep Team was ambushed by small arms and rocket fire from either side of the road at (ZC 081993) and (ZC 084992). The unit observed the enemy emplacement and TNT charges not yet set above the road in front of the sweep. Company D also found one anti-tank mine in the road at (AT 845998) containing approximately 35 pounds of TNT. On February bridges at (AT 910948), (AT 906951) and (AT 931921) were reported blown or damaged. On 7 February a mine clearing unit detonated one anti-tank mine at (ZC 081992). Ten other such mines were cleared from the area during the day. All were booby-trapped and buried approximately six to twelve inches below the surface of the earth. On the same day a Claymore type mine and a concussion grenade were found as booby traps along the road in the same area. Another mine sweep reported that during the night of 8-9 February the VC blew a bridge at (AT 910948) with 8 charges of approximately 50 pounds TNT each.

(2) Enemy Movements and Locations. Enemy identifications and locations are believed to be the same as reported last month during the early reporting period of this month. Information gained from POW interrogations and captured documents indicated that elements of the following units had displaced to the vicinity of Hue City prior to 8 February.

- (a) 11th and 12th Companies of the 804thMFBn
- (b) 802ndMFBn
- (c) C-2 and C-3 companies (probably of the 1stBn, 4thNVARegt)
- (d) Headquarters, 4th NVARegt
- (e) K4B MFBn

Later reports indicated that the 802nd and 804th Battalions would infiltrate back to their home base by way of (YD 780250), (YD 780230), (YD 920220) and (YD 920200) and cross over in the vicinity of the Truoi River south of the mountains.

b. Weather. The weather during the reporting period was cool and moist with frequent showers as well as heavy fog and low overcast during most of the reporting period. Air support was hampered considerably due to the low visibility caused by the heavy fog and low cloud cover.

a. Terrain. No change.

3. ORGANIZATION AND OPERATIONS

a. Organization. The organization of the battalion remained substantially the same through 11 February. At 120930H 1st Battalion, 5th Marines became OPCON to 1st Marines for participation in Operation "HUE CITY" which continued throughout the remainder of the month. From 11 through 13 February the Battalion Rear displaced from Phu Loc, RVN to Phu Bai, RVN. The following units were chopped from 1st Battalion, 5th Marines upon completion of the Battalion's displacement:

- (1) 3rd Plt (Rein), Co A, 1st ATBn
- (2) 1st Plt, Co C, 1st Motors
- (3) 1st Plt, Co B, 1st EngrBn
- (4) 2nd Plt, Co B, 1st SPBn
- (5) 1st Sect, 1st Plt, G Btry, 29th Arty SLT

Company E, 2nd Battalion, 5th Marines was OPCON to 1st Battalion, 5th Marines from 070930H to 081730H.

b. Operations.

(1) During the month the Battalion conducted a battalion operation along Bach Ma Road to Phu Loc Village and along Route 1, with another unit moving west from Phu Gia Fire Base and linking up with units moving east from 040745H to 061300H February 1968.

(2) The Battalion conducted a Search and Destroy operation from 071035H to 081730H in the vicinity of the Truoi River Bridge.

(3) The Battalion conducted numerous small unit operations and activities on a daily basis during the month of February as outlined below:

(a) Day activities for the month totalled 42 Fire Team activities, 76 Squad activities, 18 Platoon activities and 3 Company operations.

(b) Night activities totalled 61 Fire Team activities, 128 Squad Activities, 7 Platoon activities and 3 Company operations.

c. Supporting Arms.

(1) Air. During the month through 11 February, air performed a major role in the defense of the Battalion Assembly Area and in keeping that portion of Highway 1 that lies within the Battalion AO open for convoy traffic. Twenty-three flights of TACA/AO teams were used to help keep the TAOR under aerial surveillance and to control flights of fixed wing aircraft. Two flareships were utilized to provide illumination.

(2) Artillery. From the first through the eleventh of February Delta Battery, 2nd Battalion, 11th Marines was in direct support of 1st Battalion, 5th Marines with Lima Battery, 4th Battalion, 11th Marines providing reinforcing fires with 2 guns for units at the Battalion Assembly Area and 2 guns providing direct support for Companies C and D at the Phu Gia Fire Base.

In addition, Echo Battery, 2nd Battalion, 11th Marines provided direct support for a small operation at the Truoi River Bridge for 1st Battalion, 5th Marines and also counter-mortar support for the Battalion Assembly Area.

Most fire missions were fired in support of 2 short Battalion(-) operations, one by the Truoi River Bridge and one east along Route 1, and one two-company operation in the canopy to the southeast of the Battalion Assembly Area. Other missions fired were mostly counter-mortar. There were no confirmed results for this period.

H&Is were fired in the TAOR against avenues of approach and egress, intelligence targets and primarily against possible mortar and rocket positions.

4. TRAINING

a. From 1 through 11 February the Battalion was deployed necessitating decentralized training on the Squad and Platoon level. With the battalion actively committed to Operation "HUE CITY" for the remainder of the month, training was limited to that given replacement personnel.

b. The Battalion continued to utilize schools provided by higher headquarters. During the month, 12 members of the battalion attended schools in DaNang and Okinawa.

5. LOGISTICS

a. Supply.

(1) With the move to Phu Bai, RVN on 13 February, the Battalion Supply has been assigned a complete Butler building in which to store perishable and T/E items as well as to maintain the Battalion Armory. Concentration of work was placed on supporting members of the Battalion in Hue during the operation. A forward logistics point was established enabling smoother resupply efforts for the Battalion. An inventory of all items has been initiated to enable stock records to reflect more accurately the amount of equipment on hand.

b. Medical/Dental. With the heavy enemy activity at Phu Loc and the Battalion's displacement to Phu Bai for participation in Operation "HUE CITY," there were no MED CAPs or DENT CAPs held. There were no cases of malaria or Venereal Disease reported for the month.

6. CIVIL AFFAIRS Civil affairs activities were not conducted for the month of February due to intense operational commitments.

7. PSYCHOLOGICAL OPERATIONS Psy Ops activities were also nullified during the month due to the operational commitments of the Battalion.

8. COMPTROLLERS ACTIVITIES The month was opened with \$15,093.60 and closed with \$7,981.23. A total of \$50,000.00 was allocated to the battalion for the purchase of replacement equipment indigenous to the Battalion. A total of \$57,112.39 was utilized to purchase such items as individual equipment, jungle clothing, repair parts for weapons, gas masks and flak jackets. A total of 400 replacement personnel required issuance of equipment.

9. COMMUNICATIONS.

a. During the month of February, communications facilities were continuously improved. Overhead telephone cables were restrung after damage incurred under mortar attacks.

Considerable interference from random friendly stations continued to exist due to atmospheric conditions.

Wire/Radio Relay Communications were maintained satisfactorily by use of AN/MRC-62, providing four voice and one teletype

PART IIISEQUENTIAL LISTING OF SIGNIFICANT EVENTS

(1) 010210H 1st Battalion, 5th Marines Command Post at (ZC 076985) and CAP H5 at (ZD 086008) came under heavy mortar attack. CAP H5 was also hit with rockets and ground forces. An estimated 80 82mm mortar rounds were received throughout the attack. Counter-mortar fire was fired on suspected enemy positions at (ZC 093981), (ZC 063973), (ZC 060993) and (ZC 103989). A total of 200 rounds 81mm HE and 100 rounds 105mm HE were fired. A relief force from Phu Loc District Headquarters was dispatched towards CAP H5 at 010630H. A second relief force was dispatched from the Battalion Assembly Area towards CAP H6. And Company A was dispatched to relieve Phu Loc. Cumulative results: 1 USMC KIA, 10 USMC WIAE. The counter-mortar radar unit and searchlight at the Battalion Assembly Area were knocked out, communications were disrupted but partially restored and an undetermined amount of tentage damage was incurred.

(2) 010800H to 011900H Company B Squad Patrol at (ZD 079008) came under heavy automatic weapons and sporadic 60mm mortar fire from an undetermined number of VC at (ZD 077003) and (ZD 083010). Squad fell back under command of platoon guide and set up defensive blocking position to await remainder of company which was sweeping from the east. At 1430H Squad observed enemy attempting to withdraw via boats at (ZD 084007). A direct hit from artillery mission called by squad was observed to strike 35-40 VC massed on boats. 7 VC attempting to maneuver to squad's north flank were killed by small arms fire from Squad. Another 12 VC were killed and 1 60mm mortar destroyed by artillery mission called by squad. At 1600H 3 Vietnamese National Policemen approached squad and informed them that VC remaining to squad's east were intent upon assaulting squad at nightfall. With this, squad and National Policemen withdrew to west and subsequently effected evacuation by boat via waterfront hamlet of Gia Luong (ZD 078013). At 1645H squad was picked up by US Navy Junk Force Patrol and evacuated to the Junk Force Patrol Base at (ZD 095090). Marines were flown to 1st Battalion, 5th Marines Assembly Area on the afternoon of 4 February 1968. Cumulative results: 3 USMC KIA, 1 USMC WIAE, 54 VC KIA confirmed and 1 60mm mortar destroyed.

(3) 010915H to 011600H At 010907H word was received at the 1st Battalion, 5th Marines Assembly Area that CAP H5 at (ZD 087008) was being overrun by NVA. At 0915H the Commanding Officer 1st Battalion, 5th Marines with an H&S Company Platoon(-) reaction force departed 1st Battalion, 5th Marines Assembly

Area for CAP H5. 200 meters north of the Battalion Assembly Area, the reaction force received 6 rounds 82mm mortar fire wounding, among others, the Battalion Commander. A second reaction platoon was dispatched to relieve/reinforce the first and to evacuate casualties to the Battalion Aid Station. Upon effecting medevacs, remaining units continued to advance and came under heavy small arms and rocket fire with intermittent 82mm mortar fire. Unit was unable to advance at this time. A third reaction platoon was then dispatched. All units were consolidated and under covering fire of 100 rounds 81mm HE, a blocking position was established at (ZC 084991) to prevent enemy egress from Phu Loc. An enemy force of approximately 150 NVA was observed at (ZC 084994) moving to the southeast. An 81mm mortar mission of 50 rounds HE was directed on this force with unknown results. Dangerously short of ammunition and without further enemy sightings or contact, unit returned to Battalion Assembly Area at 011600H. Results: 8 USMC KIA, 25 USMC WIAE, 21 USMC WIANE, 11 VC KIA confirmed; 1 M-79 grenade launcher, 1 cartridge belt, 2 ChiCom grenades and 1 rain cape captured.

(4) 011620H At 010630H while at Phu Loc District Headquarters (ZD 097006), Company B was dispatched to recapture CAP H5.
